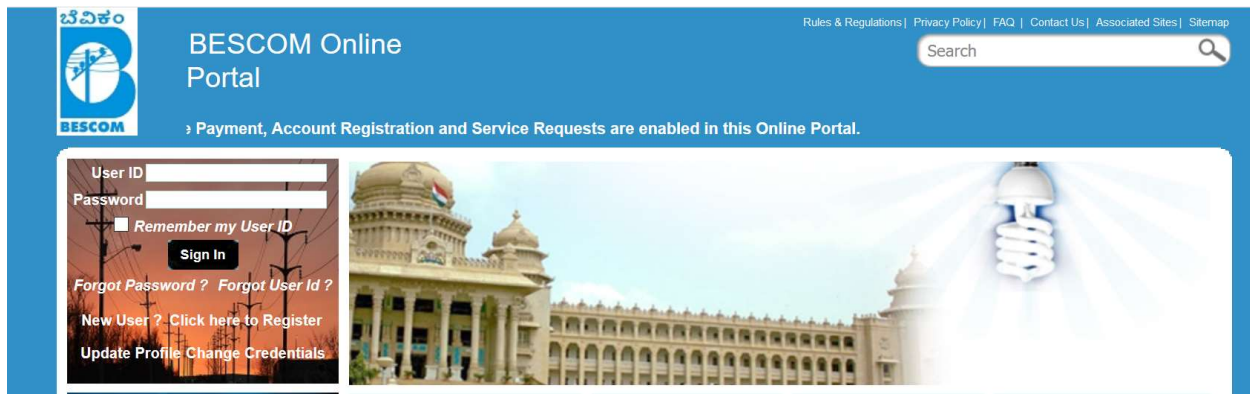




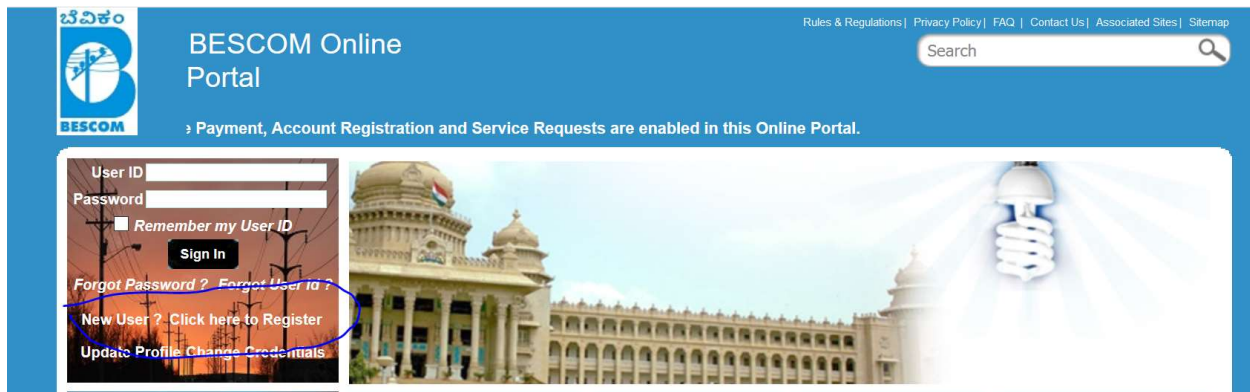
Though you fill the online form, you have to submit the offline form and comment at Bescom office. Hence feel free to decide whether you want to do on line or offline. Both steps are same though.

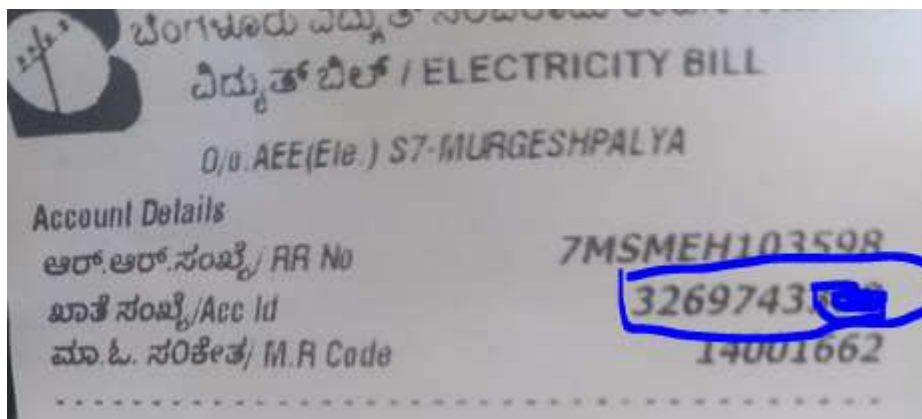

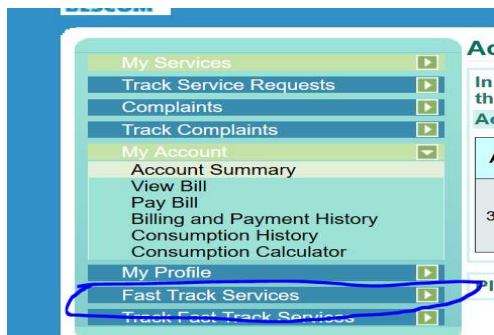

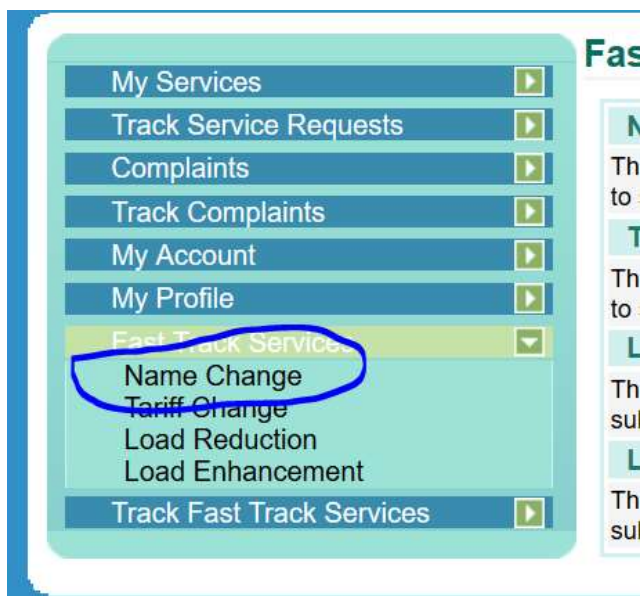
